4. FIRST AID MEASURES

ENVIRONMENTAL PRECAUTIONS

LAND SPILL: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

PERSONAL PRECAUTIONS: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. 7. HANDLING AND STORAGE

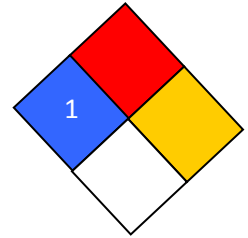
